## **Setting Successful Expectations**



## **Journey to Certification**

Intraprise Health worked with Wochos and his team to conduct an r2 readiness assessment, plans were developed for remediation, adoption, and review. Veda's systems were well-positioned, and in good shape with a level of remediation required.

Intraprise Health identified what evidence and artifacts would be needed for validation. Wochos then engaged the company to support the action plan in conjunction with Veda team members who created the documentation, policies and procedures, and provided guidance on evidence collection through the adoption review.

While Veda had an average size HITRUST assessment, with 256 requirements, they had only two CAPs. Wochos ensured that the remediated controls were implemented for 90 days while he and his team prepared for validation and conducted education across the organization.

## **Certified and Poised for Growth**

Veda earned their HITRUST certification in January 2022. Wochos stated, "The effort the Veda team put in to achieve HITRUST certification was well worth it. I am very proud of the commitment Veda has to protecting our customer's data and to our information security program in general!"

With HITRUST certification, many barriers to business growth have been removed. As Wochos said, "Many vendors require a security review, and HITRUST certification shortcuts weeks of back and forth. It's a 'badge of trust' that not many in our space have." This certification has, given Veda a competitive advantage.

The HITRUST CSF and Intraprise Health partnership has also strengthened Veda's data security and organizational resiliency. "We know what to expect now and throughout the year.
