OSIS is a national Health Center Controlled Network (HCCN) which provides health information technology support to a network of Federally Qualified Health Centers (FQHCs). Each health center is encouraged to complete an annual Security Risk Analysis (SRA) and ensure compliance with HIPAA.

In 2019, under the direction of its Security Analyst, OSIS implemented a more unified approach to cybersecurity.
